Neighborhood Events. Ms. Jayne Crumpley, 423 Elm Avenue, said contractors should clean up a work site upon completion of projects in neighborhoods and on streets. She said in August, flags for location of utilities were placed in the 400 block of Elm Avenue and after several weeks, she asked Mr. Shawn O'Leary, Director of Public Works, to please check this area and he responded quickly that it was an AT&T fiber optic project. She said the contractors dug some big holes and dirt washed into the street and the holes remained as well as the flags. She asked if she could remove the flags and she also felt a street sweeper should come clean up the street with AT&T reimbursing the city for the work.

Mayor Miller said staff will look into that.

*

Medical Marijuana. Mr. James Cook, 1819 Creighton Drive, said he represents a large group of veterans that have invested in a Grow Operation for Medical Marijuana. He encouraged Council to move forward quickly on Marijuana regulations and that the City of Moore already has a streamlined process in place by using the State regulations. He voiced concerns about delaying this permitting process because his investors had put up a large sum of money and now that money is tied up. He encouraged the City of Norman to mimic what Moore had done. He said the group would like to see indoor grow operations to be considered provisional and light industrial. He said his group is planning to grow marijuana for medicinal purposes. He said their facility is in an enclosed building and he would like to receive Special Use in Light Industrial. He said he is a University of Oklahoma graduate, had bought his home in Norman because he loved it. He said his investors are all local and they want to keep it that way. He would like clarification regarding taxation at the point of sale at dispensaries or between growers and dispensaries.

Mr. Eddie Bost, 3000 Bretford Way, said he is part of this investor group and asked Council when thinking about licenses or fees, to please take into consideration those who are local that want to serve. He said he wants people to buy from those who are local and wants the fees and licenses to be competitive.

Councilmember Scott said she is looking forward to adoption of the medical marijuana ordinance and agrees that what Council approves should be equitable to our citizens.

Councilmember Clark said she would support light industrial for indoor growing permissive use. She said she appreciates the discussion tonight about licensing for residents.

*

Portable Storage Containers. Mr. Mark Swarowsky, 9724 Lily Lane, provided handouts to City Council showing photographs of existing storage containers that are in his neighborhood, which is zoned RE, Residential Estates. He said he came before City Council approximately one year ago regarding storage containers that are infesting his neighborhood when there is an ordinance that prohibits them. He said Section 435.1 of Chapter 22 of the Norman Code of Ordinances, Portable Storage Containers and Roll-Off Trash Containers, regulates these storage containers. He read excerpts from this section. He said Section 4(d) states that these containers may remain in use only when a valid building permit is in place. He said Section 4(d) also states that a container may not be placed on the same property more than three non-consecutive times in a one-year period, failure to remove the container after the initial 14 day period, unless extended, may result in charges filed by the City for failure to comply, and may not be permanently located in areas that are residentially zoned. He said City Staff is insisting that these containers can stay permanently on a residentially zoned area which is not what the code says. He asked for Council's assistance.

Portable Storage Containers, continued. Councilmember Wilson apologized to Mr. Swarowsky for not resolving this issue with the storage containers. She said she intends to make everyone aware of the situation.

Councilmember Hickman said he is very concerned because it appears that Staff has indicated that a storage container can be placed on any residential property as an accessory dwelling unit and it is not something that he thought would have been allowed. He thinks action should be taken to clarify if the decision made were appropriate in that particular instance and whether or not these ordinances should be revised.

Item 19, Amendment to Westwood Tennis Center Indoor Facility Contract. Mr. Steve Ellis, 633 Reed Avenue said it was his understanding that the original budget for the Westwood Tennis Center Indoor Facility was \$1,000,000. He said he thought the project was over budget by several hundred thousand dollars. He said Council should decide where the money should be spent and it looks like staff made this decision to spend this money rather than City Council.

Dr. Cindy Rogers, 633 Reed Avenue, said the NORMAN FORWARD Citizens Financial Oversight Board (CFOB) gets information on decisions made by Council which is their prerogative and the Committee does not get to weigh in on the whole project. She said when an additional \$700,000 is needed for the project, where is it going to come from? She respectfully asked that this advisory board be used to give advice before a decision is made that impacts the entire NORMAN FORWARD budget. She said revenues are down about 6 percent than what was projected at the beginning of the project.

Councilmember Hickman said he agreed with Dr. Rogers. He said the CFOB has resources that should be utilized. He said if there are items coming forward in the future that are going to be impactful to the NORMAN FORWARD budget, the CFOB should be looked at for guidance and input. He said he would like for that committee to provide feedback on how the budgets appear on upcoming NORMAN FORWARD projects.

- Automobile and small truck tires (without rims)

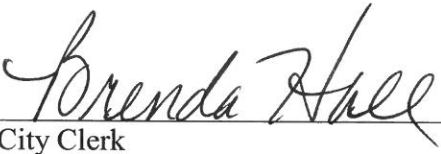
