Item 32, being:

DISCUSSION REGARDING A POTENTIAL ECONOMIC DEVELOPMENT PROJECT AT 115 WEST GRAY STREET.

Mr. Darrel Pyle, City Manager, said in the last few weeks, City Staff and some City Councilmembers were approached by a group in Oklahoma City that provides full emerging art experiences and a number of full-time jobs as well as a large number of visitors and guests to that facility which would be a big advantage to Downtown Norman. He said the question was whether or not the City Council would consider utilization of City-owned building space on Gray Street immediately adjacent to the Post Office for commercial development. He said currently that space houses the Facility Maintenance Division and provides storage space for items that will be used in the building that formerly housed the Norman Public Library during the renovation of the City of Norman Development Center. He said, with Council consensus, staff would begin to look for a site to house the Facility Maintenance Division and provide short term storage space, possibly at North Base. He said Staff believes with the conversion of Gray Street to two-way, the Gray Street property is ideal downtown property and could be utilized better. He said if Council is interested in this project, the first two things to do is find a location for Facility Maintenance and the second step is to begin conversations with the entity out of Oklahoma City

known as Factory Obscura to see what that real property transaction would look like. He said it could be a long term rental or sale. He said a higher use could be commercial development with job creation and the potential to bring visitors to Downtown. He said staff would be happy to get more involved if Council concurs.

Councilmember Foreman said she loved Factory Obscura in Oklahoma City. She said it would really be a good investment and would like to see these types of sites provide infill in Core Norman.

Mr. Pyle said one of the topics that City Staff was very aware of was the historic nature of several properties in Downtown Norman and had questioned whether some of these buildings actually provide a better opportunity for long term success for this particular use. He said they came to the conclusion that those buildings with greater historical significance would be less potentially modifiable for a Factory Obscura use and this building has little historical significance.

Councilmember Hall said she is fully supportive of moving forward and relocating City staff. She said this is the preliminary support and/or approval of learning more about the details of what may be needed. She said this is just the first step in understanding what the positive benefit would be by having Factory Obscura in Downtown Norman. She said this is just the beginning of the conversation.

Mr. Pyle said every detail would be vetted and approved step by step by City Council.

Councilmember Hall said she had comments from constituents about what this was and the lack of any kind of supporting documentation that goes along with it. She said it is important that we are clear about how we are proceeding. She welcomes this activity in Downtown Norman, it would enhance the City's art scene and she is definitely interested in pursuing the conservation.

Councilmember Bierman said she loved the idea of doing something different with buildings that are just sitting and being forgotten. She said she loved the idea of giving our art scene an injection. She said Factory Obscura is great; however, there are many questions that have not been answered, such as where do we move Facility Maintenance. A second question, do we want to be in the property leasing business once we have the empty building. If not, do we want to use the building for another city purpose or do we want to sell it. She asked if this was the highest and best use of that space and how do we best vet the possibility of other projects? She said there are many things to consider, such as how we are going to engage our community partners. She said it is possible there is someone in town with a similar plan or idea who might want to submit a bid for this space.

Councilmember Holman said he agreed this was potentially a great opportunity for Norman as a whole. He said when Council approved the purchase of the building a few years ago because of the location close to the Municipal Complex. He said that when the building was purchased, it was his understanding that it would be used for incubator/retail space to help new businesses get on their feet by providing a low cost rental space for a period of time. He agrees it should be used for a more productive purpose; it definitely is a prime piece of real estate fronting Gray Street and close to James Garner Avenue. Regardless of Factory Obscura, he prefers that it be used for something other than storage and maintenance. He said he looks forward to assessing this opportunity further.

Councilmember Peacock said he supports the relocation and the use of the property for its highest and best use. He supports continuing the conversation with Factory Obscura and is pleased to hear there is support from fellow Councilmembers. He said Councilmember Bierman makes some good points about needing to bring the public into the conversation.

Councilmember Petrone said this is the second proposal within a years' time regarding the building. She said it was important to make sure the employees that relocate will have their own space. She does agree that storage is not the best use for the property. She said she is definitely supportive of the arts. She said the first proposal was more of a Community Outreach Center. She said she is personally not supportive of selling the property and would rather it be leased.
