Mr. Steve Ellis, 633 Reed Avenue, said he was not surprised at the result of the sales tax item. He said instead of saying why the City is paying out a bunch of money for low priorities, thereby leaving nothing left for transportation. He said it is very clear that public transportation is not a priority. He said it is the Council's position that if there is not any more money raised, then public transportation is going unfunded.

Councilmember Scott said she is excited about funding public transit in the City of Norman and being able to restore Saturday service. She said she is not a fan of sales tax but she supports this sales tax increase. She said the City of Norman would not have so many issues if there were a more stable funding source. She said sales tax is extremely volatile and regressive and it cannot be depended upon. She is sorry that sales tax is what is being used for a funding source. She encouraged everyone to please vote in favor of the sales tax increase.

Councilmember Holman thanked Council for unanimously approving the Public Transit sales tax ordinance.

Councilmember Scanlon said he thinks Council did the right thing tonight. He said he looked forward to the improvements.

Miscellaneous Discussion, continued:

University North Park Tax Increment Finance District (UNPTIF). Mr. Steve Ellis, 633 Reed Avenue, said it is unclear to him about the upcoming TIF process. He said it seems clear that the City Council has completely made up their mind. He said it seems Council is just going through the motions with the final Statutory Review Committee meeting, the Planning Commission, and the two public hearings. He said if it were a relevant decision, Council would be considering a better proposed project plan.

Ms. Cindy Rogers, 633 Reed Avenue, said she appreciates that the current City Council inherited the current TIF plan and the pressure that this has put on the budget. She said it is on the current City Council to change the plan and figure out how to fix the budget and move forward in a way that is sensitive to the City's priorities. She said as a card carrying Ph.D. Economist, she is 100% certain that the terms of the plan that Council is considering will make things worse and the opposite of what needs to be done. She provided examples of how the problems could be solved.

Councilmember Scott said Council had been receiving lots of public feedback about UNPTIF and it does not look like anyone wants it to look. She said the developers want to keep it going as long as possible and there are many people who want to end it like she does. She said there are many other issues to consider right now and she does not want to get too wrapped up in one issue.

Councilmember Petrone asked the Legal Department to prepare a memorandum available to the public explaining the lawsuit challenges with the UNPTIF. She asked that the memorandum include what the UNPTIF developers are proposing so this is no longer plaguing the Facebook pages.

Presidential Candidates. Mr. Evan Dunn, 1400 Garfield Avenue, said presidential candidates, Beto O'Rourke and Cory Booker have visited Norman and he is very excited about this.

Councilmember Holman said he had the opportunity to attend the Meet and Greet for Senator Cory Booker. He said he is interested in any Presidential candidate that will come to Norman. He said there is a documentary entitled "Street Fight" about Cory Booker who was originally a City Councilman in Newark, New Jersey.

*

Paper Straw. Mr. Tom Fightmaster, 516 Hanging Elm, said he and his wife went to dinner today and they did not get a straw so they asked for one and were given a paper straw. He brought the paper straw to give to Mayor Clark.

*

September 11 Anniversary. Councilmember Scott said September 11th is the 18th Anniversary of 9-11 and expressed condolences to those who lost loved ones during that tragic event. She said she still remembers where she was when it happened. She said while Council and citizens have very passionate debates about items on the agenda, there are other things going on and we should be cognizant of that.

Councilmember Scanlon said on September 11th, 18 years ago he was at the Pentagon when the airplane hit. He said he had a friend on the opposite side of the building where the airplane hit and fortunately he got out. He saw the absolute worst that humanity can do to one another on that day. He said he also saw some of the first responders trying to help everyone. He said it moves his heart to this day. He said his hat is off to anyone who puts themselves in harm's way.

Miscellaneous Discussion, continued:

Hardie Rucker Neighborhood. Councilmember Holman said George Avenue and McKinley Avenue were in bad condition and a few years ago, Norman voters voted to extend the 5-year Road Maintenance Bond. He said this Road Maintenance Bond allows the City to rebuild neighborhood streets and it has been very effective throughout the years. He said George and Stinson were included in these projects.

Cannabis Reform. Councilmember Holman said he had spoken with three Senators about Cannabis reform, specifically in regards to banking, payment processing, expunging records of people who have been convicted of cannabis related crimes and trying to get people out of jail.

*

Anniversaries for Police and Fire Departments. Councilmember Scanlon said Saturday, September 14th is the 100th Anniversary for the Norman Police Department and this year is the 125th Anniversary of the Norman Fire Department. He said happy anniversary to both departments and thanked them for being there for him.

*

Welcome to Lee Hall. Councilmembers Wilson and Petrone welcomed Councilmember Hall to City Council.

Councilmember Bierman said welcome and thank you to Councilmember Hall for all of her hard work in the past and all the information and knowledge that she will be bringing to City Council.

Mayor Clark said kudos to Councilmember Hall for already scheduling her ward meeting.

Thanks to Ward 4 Selection Committee. Councilmember Hall thanked the Ward 4 Selection Committee for volunteering to serve and giving their time. She said Greg Jungman was the Chair of the Committee which included George Ahmadi, Andy Rieger, Lyntha Wesner, and Emily Wilkins. She thanked them as well as City Council for their vote of confidence in her. She said Ward 4 residents are engaged and passionate as demonstrated by the number of applicants who were interested in serving Ward 4 and our city. She encouraged each of them to stay involved and make a difference in Ward 4 and the City of Norman.

Ward 4. Councilmember Hall said she had spent the last few years being laser-focused on unique opportunities and challenges that Ward 4 is regularly confronted with that generally fall under the following categories: zoning, planning, land use, historic preservation, Stormwater and infrastructure, affordable housing and homelessness, and building strong neighborhood alliances. She said her intention going forward is to be a strong voice and advocate for those that live, work and play in the heart of Norman while being acutely aware of her responsibility as a Councilmember to be well informed about the complex issues that Ward 4 and our community face as a whole. She said she's ready to go to work for the City that has been home to her for 48 years. She thanked everyone for the opportunity.

*

Senior Center. Councilmember Petrone said she received emails from Dave Boeck and Bette Maffucci as well as some others regarding the Senior Center. She reiterated how important it is that Staff reaches out to the Seniors in this community about the Senior Center. She asked that a letter be sent out directing them to a questionnaire and letting them know how important they are to us.

Miscellaneous Discussion, continued:

Floodplain Meetings in Ward 3. Councilmember Petrone said the floodplain meetings for Wards 3 and 8 are finished and now the ward can move on to other issues.

*

Churches Caring for Creation. Councilmember Bierman said she met with City Manager Darrel Pyle as well with one of the members of Churches Care for Creation because they wanted to discuss recycling Styrofoam. She said Styrofoam does not biodegrade, it can last in a landfill for 500 years, and it is considered one of the toughest single use products to clear out of the environment. She said 80% of it ends up in landfills and 20% end up in the waterways. She said Styrofoam is recyclable and Churches Caring for Creation decided that they wanted to take up the challenge. She said there is a company called Dart Corporation that recycles Styrofoam. She said they use the Styrofoam to make parts for other things; they make lightweight airplane components and parts for mobile homes, etc. She said the Styrofoam drop-off center in Ada. There are three churches actively recycling Styrofoam, University Lutheran Church, St. Michaels Episcopal Church, and First Christian Church. She said since April they have collected and transported 229 thirty-three gallon bags full of Styrofoam to Ada and that includes rinsing and stacking it. She said she has discussed setting up a way for the City of Norman to recycle Styrofoam. She said citizens will be able to recycle Styrofoam at the Household Hazardous Waste Event on November 2nd. She urged people to start collecting it now and separate the Styrofoam for packing from the Styrofoam related to food. The three churches have volunteered to sort it and transport it. She said the City of Norman will take some of the dumpsters that are no longer in use and repurpose them into Styrofoam drop-off centers. She said Mr. Pyle will be reaching out to Dart Corporation to purchase the Styrofoam. She said if a pilot program proves effective, the City of Norman will be the first City in Oklahoma to recycle Styrofoam.

Ward 8 Meeting. Councilmember Scott announced a Ward 8 meeting at the Fire Station No. 7 on Sunday, September 29th from 1:30 to 3:00 p.m. She said the focus will be the environment. She said members of the Sierra Club will be speaking about “Ready for 100,” which is 100% Renewable Energy by 2040. She said the OG&E Franchise agreement will be discussed. She said Amanda Nairn, Chairman of the Environmental Control Advisory Board, will be at the meeting to provide information about “Ready for 100” and Mayor Clark will be there to discuss Public Transit.

Ward 7 Meeting. Councilmember Holman said he planned to have a ward meeting in mid-October to discuss the sales tax proposal for public transit. He said some of the NORMAN FORWARD Projects in Ward 7 will also be discussed.

Ward 6 Meeting. Councilmember Scanlon announced a Ward 6 meeting on Monday, October 7th at 7:00 p.m. at the 12th Avenue Recreation Center. He said Shawn O’Leary, Director of Public Works, will be there to discuss public transit and the sales tax election.

Ward 5 Meeting. Councilmember Wilson said she has a Ward 5 meeting every month and this month’s ward meeting will be Saturday, September 16th at 10:30 a.m. at Thunderbird Baptist Church, which is on the south side of Highway 9 from Clear Bay entrance at Lake Thunderbird.

Ward 4 Meeting. Councilmember Hall said there will be a Ward 4 meeting on Wednesday, September 25, 2019, from 7:00-8:30 p.m. at the Norman Central Library in Rooms A & B. She said this will allow her the opportunity to meet more people in Ward 4 and to listen to their concerns.

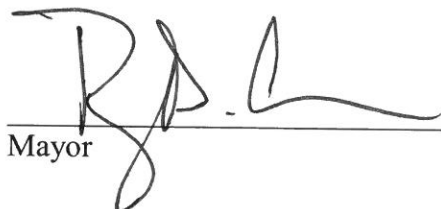
