Approval of Minutes Brewer motioned to approve the minutes from the last meeting. Green seconded the motion.

FY'25 Budget Discussion Schemm provided an overview of the budget approval process and presented the VisitNorman/Norman Sports plan of work for the next fiscal year. The budget, totaling just over 2 million in guest tax revenue, was discussed along with its relationship to the city's fund account. Schemm elaborated on the allocation of funds, including \$1500 for monthly occupancy/daily rates research and \$27,000 for Datafy software and cell phone tracking, with approximately a month delay on information retrieval.

Blaze Brand Presentation Schemm outlined the Request for Proposal (RFP) process that led to selecting Blaze as the company to conduct branding for both VisitNorman and Norman Sports, marking the first logo redesign in approximately 15 years. Jeffri-Lynn from Blaze then presented the branding proposal to the board.

Resume FY'25 Budget Discussion Schemm discussed the allocation of funds for various marketing initiatives, emphasizing the importance of targeting leisure and business travelers. Budget allocations included VisitNorman (40k) and Norman Sports (120k) bid fees, venue enhancement funds, annual tourism luncheon, and Norman Sports Hall of Fame dinner.

Schooner on Parade Schemm announced plans to collaborate with OU on creating a Schooner on Parade fundraising event, with the aim of unveiling the first one by July 1st, 2024, in time for the SEC kickoff party hosted by OU.

Weather Museum Update Schemm highlighted the significance of potential funding from the city council's approval of the GO bond for the proposed new weather museum experience.

Mountain Bike Trail Update Schemm provided an update on the progress towards submitting documents to the B.O.R., noting that additional technical specifications were requested. It was mentioned that there might be an opportunity to utilize 1 million of ARPA funds from the county.

Adjournment Alison motioned to adjourn the meeting, which was approved by Howard. The meeting adjourned at 1:01 p.m.
